MODULE DESCRIPTION

This module delves into cutting-edge research and emerging trends in language studies, with a focus on interdisciplinary connections between linguistics, education, and psychological sciences. Topics include neurolinguistics, language acquisition, multilingualism, sociolinguistics, and the role of language in cognition and identity. Students will critically engage with current debates and explore how advances in sciences are reshaping our understanding of language and its role in society. The module encourages students to reflect on the implications of these developments for teaching, learning, and research in language studies.
