MODULE DESCRIPTION

This course introduces related theories of Chinese and Western music and the art of film, aiming to nurture aesthetic appreciation from the perspectives of feeling, understanding, creating, expressing, and analyzing. Students will study internationally acclaimed films, enriching their audio-visual sense of beauty and establishing good habits in the culture of music and film. The curriculum covers a wide range of topics, including an overview of film history (Western, Eastern, and Chinese cinema), film classification methods, and the exploration of film music and genres.

Key areas of focus include the role of music in evoking emotions and the elements of music, along with a detailed investigation of the film and film music production process. The course delves into historical contexts, early film music trends, and the impact of music in various film genres such as Westerns, horror, romantic melodramas, war films, documentaries, musicals, and animation. By the end of the course, students will have a comprehensive understanding of the interplay between music and film across diverse genres and historical contexts, enhancing their critical analysis and aesthetic appreciation skills.

M4.	Understand filming techniques such as camera usage, lighting, and editing, and how film music complements these elements.
M5.	Distinguish among major music styles including Western classical, traditional Chinese, and contemporary popular music from both the East and West.
M6.	Understand the roles film music plays in setting contrast, aiding narration, and the interaction between visuals and music, along with the relationship between directors and film composers.
