LEARNING MODULE OUTLINE

MODULE DESCRIPTION

This course familiarises the students with the basic practice of literary translation, the most common problems that appear in literary translation, as well as techniques and strategies of producing literary translations that faithfully serve the original and at the same time stand as works of art in their own right within the linguistic and cultural context of the target culture.

The course consists of one hour of lecture and one hour of seminar per week. In the seminars, the students will present/discuss their readings of discursive writings by major scholars on different aspects of literary translation. This will help the students to gain theoretical / critical insight into this field of study.
