MODULE DESCRIPTION

This module is designed to develop research and writing skills for non-native English-speaking students enrolled in the Chinese/English Translation Program at MPU. It will be an intensive hands-on experience that requires the extensive use of library paper and electronic resources and constant practice to put ideas on paper in terms of sentences, paragraphs and papers/essays. It will familiarize the students with the FLT graduate thesis writing requirements and expectations, emphasizing on the fight against plagiarism. The reference formats such as MLA and APA will be briefly studied.

MARKING SCHEME
