MODULE DESCRIPTION

This one-year First Year English course aims to increase students' exposure to different contexts of using English for authentic communicative purposes. Basically, the four macro-skills are covered. Students are encouraged to build their confidence in expressing themselves in English through various activities and tasks. In addition, 20 hours would be used as the beginning part of developing students' English reading, writing and speaking ability required as a nurse. Emphasis is placed on the medical terminology about health concepts, diseases and other nursing terms.
