A2. Group work and presentation Students will form 5 self-selected groups in each class. Groups will select a topic via a lucky draw. Requirements are: - 20-30 minutes oral presentation - Use of PowerPoint for presentations - Submission of the PPT file on the day of presentation	40	M1, M2, M3
A3. Individual assignment - Theme: "Career planning and professional growth" - Students are expected to submit a 3000-word ($\pm 10\%$) paper	40	M1, M4

Each assignment activity is graded on a 100-point scale. The final grade will be calculated based on the weighted average of these activities. Assignments must be submitted by the designated deadline. Submissions received after this deadline will have a 10% reduction in total possible points per day of delay (For example, an assignment scored at 80 points, submitted one day late, will be reduced by 8 points to 72 for the final weighted grade.).

The assessment will be conducted following the University's Assessment Strategy (see www.mpu.edu.mo/teaching_learning/en/assessment_strategy.php). Passing this learning module indicates that students will have attained the ILOs of this learning module and thus acquired its credits.
