MODULE DESCRIPTION

This module provides a concise overview of the grammatical structures of Modern Standard English, aiming to enhance students' proficiency in the language. It covers core topics in English grammar, including words and their inflectional forms, word classes and phrases, semantic roles and grammatical functions, clauses and subordinate clauses, tense and aspect, as well as mood and modality. Students engage with authentic language data to facilitate their learning.

MODULE INTENDED LEARNING OUTCOMES (ILOS)

On completion of this learning module, students will be able to:

M1.	Through the analysis of authentic language data, students examine the internal structure of words and explore the grammatical significance of various inflection.
M2.	Through the systematic examination of authentic language data, students identify and analyse various word classes and phrases, investigating their respective roles and functions within grammatical structures.
M3.	Through the analysis of authentic language data drawn from domains including public administration, tourism, commerce and mass media, students develop the ability to construct extended and syntactically complex structures by employing both coordination and subordination strategies.
M4.	Through the systematic examination of authentic language data from key domains including public administration, tourism, commerce and mass media, students acquire a thorough understanding of fundamental grammatical concepts, encompassing number, agreement, tense and aspect, voice and finiteness.
